PCG – Quality Family

Member led

- Promoting the value of and raising perceptions
 - Being professional in what you do and how you operate
 - Being credible about what you do
 - Raising the business aspirations and opportunities for members
 - Improving members skills and capabilities to move higher up the value chain



It started...











Choosing an accountant is an important decision for any freelance consultant or contractor. Whether the need is only for help with drawing up accounts and calculating corporation tax at year-end or for a full-blown accounting and bookkeeping service, the relationship is likely to be a long-term one that needs to be chosen carefully.



How does it work?

- The PCG (QA) scheme is restricted to accounting practices with one or more qualified partners or practitioners
- We envisage accrediting no more than one or two practices in a given geographical or postcode area
- Strict entry criteria only chartered and certified accountants and chartered tax advisers are eligible
- Training on IR35/S660A
- Customer service training to enable accountants to meet the needs of freelance consultants and contractors
- Annual assessment, including feedback from PCG members



PCG(QA) – Quality Accountant


PCG(QA) – is member led

A membership survey has helped define the scheme



- Demonstrates that you manage your business financial affairs professionally

PCG's new PCG (QP) scheme enables members to have their CVs certified to BS7858.

Developed in collaboration with Background Checking, the scheme provides a full check in the first year and an annual renewal check in subsequent years, enabling members to have an ongoing and updated CV to offer to agencies and clients at any time.

What is it all about?

- Obtaining certification to ISO 9001:2000 quality standard
- Certificating body is BVQi
 - Full certification
 - Not a cut down version
 - Has same value as any other BVQi ISO certificate
- BVQi do not issue second class ISO certificates

Requirement for ISO 9001

- Decision made April 2004
- Mandatory requirement of safety process in core business sectors
- Necessary in order to maintain existing client base let alone expand it



Options Available

- Undertake the work internally
- Engage external consultancy
- PCGQS

Undertake Internally

- Limited experience with ISO 9001:2000
 Large amount of work to develop QMS
 Risks:
 - Ensure QMS and procedures ISO 9001 compliant
 - Then demonstrate company adherence
 - No backup for advice and guidance
 - Longest timescales for ultimate certification
 - Greatest risk of failure

External Consultancy

Relatively high cost - circa £12k +

- Mainly providing guidance
- Transsol responsible for producing all mandatory components and having these assessed against requirements of ISO 9001:2000
- Consultancy would 'review' and 'comment' on above
- Consultancy would 'facilitate' certification process
- Potential for further un-quantified costs
- No guarantee of success

PCG(QS)

Relatively low cost - circa £2k

- Real value of PCGQS
 - Economy of scale
 - Fixed budget to certification
 - Includes all mandatory components (e.g. QMS).
 - All of the components of PCGQS have been produced by professionals and assessed to be compliant with requirements of ISO 9001:2000 by BVQi (ISO 9001 accreditation body)
 - Full support of PCG and its main consultant (BQI)
 - Includes bespoke electronic document management system
- No guarantees but lowest risk of failure
- Final analysis Decision was obvious

The Decision

- 'No brainer'
- PCG(QS) offers:
 - The most likely road to success
 - Unrivalled technical support
 - Economies of scale and hence costs
 - The whole QMS environment is included in the scheme

The Rewards

- ISO 9001 certification well received by existing clients
- Enables the company to develop autonomously in its core business sectors
- Transsol has been able to tender for:
 - Contract with ROTEM for safety case work.
 - Framework Agreement with Tubelines.
 - Table top safety exercise for Transpennine Express.
 - Training provider to Network Rail.
- Transsol has won contracts with:
 - Network Rail (safety assessment for power supply upgrades)
 - Optilan Communications
 - Extensions to existing contracts with URN and C I Kalogritsas
- Invited to present a paper on Athens Metro Experiences at IEE International Conference of System Assurance



Summary

Obtaining UKAS accredited ISO 9001:2000 quality standard has enabled Transsol Ltd to develop from a small contracting entity with limited market potential into a serious business with industry wide appeal.

The modest costs associated with PCGQS are disproportionate to the real and tangible benefits that certification provides.

The Certificate



Launched June 2005

- 15 fully certified
- 121 various stages of being certified
